- Only archived personal data strictly necessary for the purpose of protecting the corporate assets of Akifix S.p.A. by ordinary and extraordinary maintenance of hardware and software used, as well as electronic mail;
- By way of example, your business name, information relating to your payment and, in any case, what is strictly necessary in order to use the functions of a business information platform;

Your rights:

You, as an interested party, can exercise the right to:

- Check the categories of recipients of your personal data processed;

- Verify the retention period of your personal data processed;

- Verify the possibility of exercising the right to rectify your personal data processed, deletion of your personal data processed or limitation of the processing of your personal data processed;

- Check the possibility of proposing a complaint to the Guarantor for the protection of personal data;

- Verify the use of an automated decision-making process and, if so, the logic used;

- Correcting your personal data processed, pursuant to art. 16 of the reg. (U.E.), in case of inaccuracy of the same;

- To obtain the cancellation of your personal data processed, pursuant to art. 17 of the reg. (U.E.), without prejudice to the existence of a legal obligation to the contrary or the presence of the need to treat the same for purposes of assessment, exercise or defense of a right in court, in case of:
 - The absence of the need to treat them for the stated purposes has passed;
- Preventive or simultaneous withdrawal of consent to the processing of the same;
- Estimate assessment of the unlawfulness of the treatment of the same;
 - The existence of an imposing legal obligation to cancel them;
- To obtain the limitation of the processing of your personal data processed, pursuant to art. 18 of the reg. (U.E.), in case of:
 - Contemporary contestation of the accuracy of the same, limited to the period necessary to allow Akifix S.p.A. to verify this accuracy;
 - Estimate of the unlawfulness of the processing of the same and subsequent opposition to their cancellation;
 - The presence of the need to treat the same has been verified for the purpose of ascertaining, exercising or defending a right in court;
 - To obtain, in a structured format that is commonly and automatically readable by automatic device, your personal data processed and, if necessary, obtain communication of the same to another data controller, pursuant to art. 20 of the reg. (U.E.), with regard to the processing of personal data aimed at communicating via e-mail news relating to the economic activity carried out by Akifix S.p.A and the events organized by the same.
